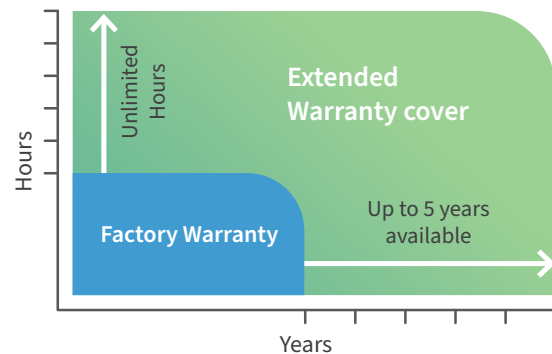
## Warranty
